NARRATIVE:

I received confidential information from the Village of Wellington representatives, specifying the precise location of the stolen Baby Jesus, as 12026 Suellen Circle, in Wellington. I knocked on the front door and was greeted by Mrs. Vania Silva who invited me and Detective Read, inside the house. Once in the living room I observed Baby Jesus face down on top of miscellaneous items on the floor. I asked Vania where did she get the doll?. And she replied that her son Fernando who is sleeping in his bedroom brought it home sometime last night. Vania said that she took the doll out of her son's bedroom at approximately, 4:00AM and placed it in the livingroom. Detective Read, read Fernando the Miranda Warnings, after which Fernando provided a sworn written statement, naming a girl Danielle who he has no further information on, as the one that "came back with the stolen property, set it down, I asked what it was and she replied, I STOLE JESUS". I further investigated the case and was able to locate and identify Danielle Kristine Santino DOB of 09/14/89 as the person who actually committed grand theft of the Baby Jesus doll, on 12/26/07. Danielle turned herself in and after I read her the Miranda Warnings, she provided a taped statement confessing in detail to the above Grand Theft.



