The defendant and victim parked their vehicles in a parking of the 2100 Blk. of Park Av. They both exited their vehicles and walked towards each other. At that point, the defendant shot at the victim. The victim turned and began to run northbound from the defendant. The defendant then shot the victim in the back. The victim stumbled and fell to the street curbside. Miami Beach Fire Rescue responded and Lt. Howarth administered treatment. Moments later, Lt. Howarth advised that the victim was deceased. The defendant fled the scene, northbound in his vehicle. A B.O.L.O was issued for the defendant's vehicle, which was a yellow taxi with the number 844 affixed on the rear back window, upper left corner. Seconds later, Ofc. J.Mauro # 219 and Ofc. J Metzgar # 352 observed the vehicle matching the issued B.O.L.O , speeding Northbound on 27th Street and Pine Tree Dr. The vehicle turned west on 40th Street, as Ofc. Maruo and Ofc. Metzgar

followed. The Officers initiated a felony traffic stop on the yellow taxi matching the issued B.O.L.O. and apprehended the defendant. The defendant was transported to the station. Post-Miranda the defendant admitted to shooting the victim and the fleeing the scene. The defendant stated that he had several arguments with the victim in the past three weeks and that today when the victim followed him he armed himself prior to confronting him with the intent to kill him. Pursuant to a search warrant of the defendant's vehicle a six-shot revolver was located in a tool box in the center console. Examination of the firearm revealed four spent casings in the cylinder of the firearm. The defendant was arrested and transported to DCJ..
